Dear Mr. Keglovits:

On January 9, 2020, Guardian Pipeline, L.L.C. (Guardian) filed tariff records¹ to reflect an update to contact information and to update the reference in its tariff of a uniform resource locator designating a location on the Internet of its system maps. The tariff records listed in the Appendix are accepted effective February 10, 2020, as requested.

Public notice of the filings was issued on January 13, 2020. Interventions and protests were due as provided in section 154.210 of the Commission's regulations (18 C.F.R. § 154.210 (2019)). Pursuant to section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission's (Commission) regulations, Guardian Pipeline, L.L.C. (Guardian) respectfully submits for filing and acceptance the tariff record listed below for inclusion in its FERC Gas Tariff, Volume No. 1A (Tariff). The proposed tariff record is submitted to become effective February 10, 2020.

Statement of Nature, Reasons, and Basis for the Proposed Changes
